# Active Projects Lamar Building

Potential investors in town August 12 for tour and meeting with DDA.

They will finalize agreements in October/press conference.

Anticipated construction start date of January 2026.

Working with Cal Wray on possible new market tax credits.

#### Ramada on Broad Street

Hotel has closed and new owner Breakwater Development has started construction drawings. Financing has been secured.

176 Rooms with meeting space, ballroom space and full service restaurant. Hanks Seafood to consult.

Developer has the ground lease for 3000 SF of retail across the street and outdoor seating space.

Financial Impact Study has been completed by Georgia Power.

"Happy Hour" meeting with City on Sept. 25 and was a tremendous success.

Developer has met with Commissioners Jordan Johnson and Francine Scott and Mayor Johnson.

Marriott in town September 15 for a tour and dinner at Sole.

## **Curtis Baptist Church Site-Framework**

Closing on property has been extended until Q2 2026.

Designing the entire site (7.2 acres) instead of two phases.

#### **Outdoor Adventure Center**

Funding sources have been identified and contracts have been executed with the city.

Waiting on approval from the Corps of Engineers in the next 30 days.

Anticipated start date is October with a completion date of Spring 2026.

## **Carl Vinson Downtown Visioning & Design**

Presentation for Destination Augusta May 21.

Meeting with Commissioner Johnson and City Administrator on May 22. Ready to move forward on building registry and revolving loan fund. Working on powerpoint presentation to present to commission.

#### **Broad Street TIA Project**

We submitted a letter of support signed by the DDA, Augusta Metro Chamber and Destination Augusta requesting the commission to enforce 2 hour parking during TIA construction.

Public Meeting held May 21 at Fatman's was well-attended.

James Brown Linear Park construction has started. One lane of traffic is open on both sides of the street and there has been NO problem with access to lower Broad.

Broad Street construction to begin in late October starting at 13th street.

Paquin PR Firm has been hired for messaging. ZOOM meeting held Sept. 4.

# **Jones Street Alley Improvements**

Meeting with Nathan Vick on May 21 to discuss next steps with HPC.

All parties have signed off on concept drawings and construction documents are underway.

#### Soofa Kiosks

\$3500 to replace the screen and \$2000 allowance for vandalized wrap.

## **Chronic Vacancy/Blight Initiative**

Meeting with City Administrators Office April 23.

The overall concept was well -received.

- 3-prong approach:
- Building Registry
- Revolving Loan Fund. (meeting with Stacey Tallent May 29 to establish parameters).
- Empty Building Tax.

We are working on other funding mechanisms and preparing a power point presentation to present to the commission.

## **Mothballing Ordinance**

Urbex trend.

Lamar, Embassy Suites site, Ramada challenges.

Meetings with Sherriff's office May 30 and August 11 to discuss a possible solution.

Looking at a model similar to site maintenance in place with the city.

Will bring back to the board for approval.

#### Other:

Budget hearing with city was held September 12 at 2 pm.

Performance measures are now required. We submitted net gain new businesses, net gain job creation, private investment, public investment and new housing units.

Budget shortfall of \$69,000.

DDA offices are the holding area for curfew violators on Friday and Saturday nights for parents to pick up offenders.
